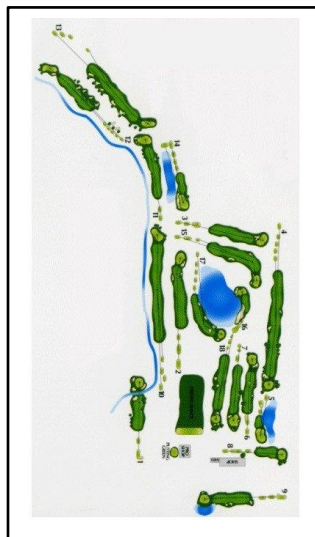

Annually MGC will communicate with all sponsors regarding renewal of this agreement and for invoicing of the Sponsorship Fees for the coming year. This communication will be mailed 60 days prior to the annual renewal date of April 1 of each year.
2. Sponsor Obligations. For its participation as a Sponsor in the Tee Sign Sponsorship, Sponsor shall pay to MGC a fee (the "Sponsorship Fee").
3. Limitation of Liability. In no event shall either party be liable to the other party for any incidental, consequential, indirect, or punitive damages (including but not limited to lost profits) regardless of whether such liability is based on breach of contract, tort, strict liability, breach of warranties, failure of essential purpose or otherwise and even if advised of the possibility of such damages.
